1/17/2024	Unhappy with accident invest from May 2023	Sustained	Additional investigative steps were warranted. Investigation amended to reflect proper outcome.
2/16/2024	Claims to be missing piece of jewelry from his luggage but not saying police did anything wrong	Unfounded	Subject was trespassed from local motel and severely intoxicated to the point of requiring transport to hospital. BWC footage clearly shows his luggage to be stowed and secured with a wire. At no time was the luggage opened or inventoried. It was intact during all interactions until custody transferred to hospital staff.
2/20/2024	Officer actions regarding traffic stop	Unfounded	Complainant was passenger in a vehicle stopped for operating unregistered. Felt Officer should have arranged for transportation of all passengers after the car was towed. Ofc offered several options which were rejected.
2/21/2024	Officer's handling of complaint	Summary Action	Officer counseled regarding the need to communicate with the complainant on investigative outcomes.
2/21/2024	Claims several perceived procedural violations when Officers arrested him for several offenses concerning an incident involving a firearm / Also claimed two moving violations by Officers	Unfounded / Summary Action	Complainant's claims of procedural violations during his arrest were unfounded. Officers counseled regarding expectations concerning vehicle operations
3/10/2024	Claims that Officer touched his private area during search	Exonerated	Complainant was arrested for a violent felony involving a firearm. Officer was required to complete a thorough search of the prisoner when taking him into custody especially considering the firearm had yet to be located. Policy and procedure were followed.
6/21/2024	Unhappy with MV Stop, including the length of stop and steps taken	Sustained/ Exonerated	Complainant was stopped for documented moving violation. Length of stop found to be appropriate; however, Ofc found to have committed procedural errors. Corrective action taken to include remedial training
7/12/2024	Claim he should have been sent for emergency examination instead of being arrested	Unfounded	Officer had probable cause for a DV related arrest which was warranted; however, they lacked the information necessary to meet the threshold for an emergency examination referral
8/9/2024	Unhappy with MV Stop	Exonerated	No policy violation; however, Sgt met with Ofc to discuss some lessons learned re communicating additional information to person stopped.
